- **Libyan Claims Resolution Act, report language request**  
The Secretary of State is directed to disburse all monies remaining as of May 22, 2013 from the funds received by the United States, and held by the U.S. Treasury, pursuant to Public Law 110-301 to compensate United States Nationals who held judgments pursuant to 28 USC Section 1605 (a)(7), against the Great Socialist People's Libyan Arab Jamahiriya on or before August 4, 2008; Provided that \$3,000,000 be provided to injured United States Nationals whose claims for physical injury were previously denied by the Foreign Claims Settlement Commission for failure to plead for injury other than emotional injury alone provided that the United States Nationals were a named party in litigation previously considered by the Foreign Claims Settlement Commission whose litigation against the Government of Libya was dismissed before submitting to the Foreign Claims Settlement Commission and who have not received any compensation under the Libyan Claims Settlement Agreement.

The Committee encourages additional surveillance by CDC of Tuberos Sclerosis Complex (TSC) and related disorders toward understanding how the various manifestations of TSC, and the clinical management thereof, impact health outcomes and quality of life. Because TSC is a leading genetic cause of more prevalent neurological disorders such as autism and epilepsy, the Committee encourages CDC to focus resources on improving diagnosis, surveillance and management of TSC as a model for methods that can be applied to more prevalent related disorders.

*Minority Participation in Clinical Trials.*—The Committee is concerned that African-Americans and other minority groups have disproportionately high cancer rates while their enrollment in clinical trials remains disproportionately low. Only 2 to 4 percent of African-American cancer patients enroll in trials, a rate well below the average. Without more diverse participation, it can be difficult to determine whether new therapies will be safe or effective for patient groups that are not well represented in the clinical trial population. African-Americans represent only 5 percent of total clinical trial participation, making conclusions for this population nearly impossible. Therefore, the Committee encourages NCI to take all possible steps to expand the enrollment of African-American and other minority patients in clinical trials, particularly trials of novel immune therapeutics and molecularly targeted therapies.

*Behavioral Research and Cancer.*— The Committee urges NCI to prioritize research on how to prevent disease and increase early detection in minority and disadvantaged populations facing significant cancer health disparities.

*Research Centers in Minority Institutions* – Research Centers in Minority Institutions (RCMI) play a critical role, especially at the graduate level, in addressing the health research and training needs of the nation. The NIH is expected to maintain a robust level of support for the RCMI program.
